

Ocean Society of India Prof. R. Ramesh Endowment Award 2024



Announcement

The Ocean Society of India (OSI) is pleased to announce 'Prof. R. Ramesh Endowment Award 2025' in the fond remembrance of Prof. R. Ramesh, who was a distinguished scientist at the Physical Research Laboratory in Ahmedabad, known for his significant contributions to climate and ocean sciences, particularly stable isotope geochemistry, paleoclimatology, paleoceanography, biogeochemistry, and climate modelling. This award is to honor young Indian Scientists/Researchers who made outstanding contributions in the field of Climate and Ocean Sciences. The scientific contributions should cover any aspect of ocean biogeochemistry, paleoclimatology, paleoceanography, isotope hydrology and meteorology, and isotope-enabled climate modeling.

Prof. R. Ramesh Endowment Award 2024 is open to all Indian citizens under 45 years of age as on 1st January 2024 engaged in research activity related to Climate and Ocean Sciences in the themes cited above on the basis of work primarily carried out in India. The award carries a citation, medal and a cash prize. The award will be presented during OSICON-25, the biennial Conference of OSI which will be held at CSIR-NIO, Goa during 5-7 February 2025.

Nominations for this award are invited from the Secretaries of Government Scientific Ministries/Departments, Heads/Chairpersons/ Presidents/ Directors of Institutes/Centres/ Science Academies /Scientific Societies/University Science Departments/ Institute Scientific Divisions or by Rashtriya Vigyan Shri Puraskar/Shanti Swarup Bhatnagar Prize winners or by Fellows of OSI/ National Science Academies. Final selection will be done by a duly constituted Award Committee based on evaluation of all nominations received. Nominations received will be valid and considered for a period of four years or attaining the age limit of 45 years as on the first date of the award year whichever is earlier.

The last date for receiving nominations is 4^{th} December 2024. Self-nominations will not be accepted. No subsequent correspondence on the nominations will be entertained by the OSI.
